
### SHELL SCOTFORD COMPLEX REFINERY AND UPGRADER FORT SASKATCHEWAN, AB

## **Fabrication & Modularization**

Our three fabrication shops, located in Bonnyville and Cold Lake, AB and Saskatoon, SK, are where we self-perform a range of module, piping and vessel repair activities to support our clients. In doing so, we maintain tighter controls of a project's quality, cost and schedule. We work with Carbon, Stainless, Chrome, Hastelloy, Monel, Iconel; FRP and HDPE; Module Erection, in-house welders, pipefitters and QC for fabrication, NDE, and hydro-testing.

Our facilities are strategically located to support our field operations and client requirements. We have experience delivering customized pipe fabrication and a broad range of module fabrication and assemblies.

Additionally, Graham has partnered with Indigenous organization Seven Lakes Oilfield Services (SLS) to help them develop their structural steel fabrication offering. Graham is committed to engaging SLS on applicable scopes, wherever it is appropriate and a best-fit. Graham's comprehensive fabrication and modularization capabilities include:

- Fabrication shops of varying capacities and strengths, ranging from custom fabrication spaces, to acres of modular assembly yards and storage.
